Arrived on site at 15:40 on 5-29-2018. It was raining and temperatures were in the 60's. Release went south off the well pad behind the central tank battery. Walked behind the tank battery and saw the area scraped. Off pad there appeared to be no left over contamination; however, there is still staining on pad. The contamination also appears to be stockpiled on site. Further follow-up is needed.
