On 9/6/2018 at 6:08 pm - Sunny and 79 Degrees F - I visited the Continental Resources - Rennerfeldt 2-30H production location. It appeared that a light mist of crude oil drifted from the well head to the NW across the location approximately 50 yards to a wheat field at the NW corner of the location. An area approximately 40 feet east to west and 30 feet north to south in the wheat field at the NW corner of the location appeared to have been lightly impacted by crude oil. There appeared to be some crude oil impacts to the location as well.
