Arrived on site at 14:15 on 11-19-2018. It was cold with temperatures in the teens. The release went off site north of the well pad and impacted a 15 by 20 foot area. Talked to a Newfield representative who said a skid steer came and cleaned up the contamination. The responsible party plans to spray down the central tank battery at a later date. A vegetation check should be made next year in the spring.

Arrived on site at 12:00, weather was overcast with wind out of the NW at 20 miles/hr. Temperature of 60 Degrees F. The area now has good vegetative cover with a cover crop of grains, grasses and native flowers growing. No visible signs of oil stained soil. No additional follow-up needed.
