4/20/2017, on location. It had rained in the area recently, so some standing water on the curb of Normandy Street was visible. The water had some visible staining, but it appeared to be limited to parts of the curb already impacted during the initial spill (i.e., the spill does not appear to be migrating, even with the rain). Curb shows visible signs of staining, while one of the concrete driveway aprons shows some light staining. Could not see any visible discoloration on the asphalt roadway of Normandy Street, so it does not appear that the hydraulic fluid is affecting the roadway. Nearest stormwater drain that could be located is on Versailles Avenue, approximately 700' away. No other impact visible. According to recent conversation with Butler (5.5.2017), Arrow Cleaning was back out to the site to clean the curbs. No further follow-up required at this time.
