Drum was loaded into 53' van trailer improperly and during transport the load shifted causing the drum to leak.

Soil and surface water. All impacted materials have been removed from site.

Action Taken/Planned:

The spill was contained via buckets from the spots dripping from trailer. Due to the remoteness of the site and availability of qualified contractors response did take some time. Once on site the contractors identified the spilt liquid and began remediation. The trailer was unpacked and contents cleaned as well as the pooling rain water surrounding the trailer was removed via a vacuum truck. Once all materials were removed soil excavation was completed in the areas the liquid had impacted surface soils.
