NDDoH was contacted a few hours after incident occurred. NDDoH made recommendations for cleanup and has been coordinating with the Rolette County (covering Towner County as well) emergency manager who has been checking on the cleanup. Pictures and reports submitted by the Emergency Manager (EM) has been placed in the file. EM estimated 412.5 gallons were lost of the 550 gals possible (two 275 gallon totes). Excerpt from EM's report: "Paint truck was north bound on Hwy 281, wooden side rails broke off that contained the paint shuttles, shuttles fell off truck causing the plastic shuttles to rupture upon impact with Hwy, covering north bound lane, shoulder, grass, cat tails and water of slew. From point of impact to end of spill is approx. 68.17 yards". Since the incident, conversation with the EM and the company indicated that the paint in the slough has been sucked up, and a contractor was being hired to scrape up the impacted vegetation and soil as well as remove the impacted cattails. EM will be following up on the site periodically.
