Cause of Incident:

Leak noticed during transformer maintenance. The leak slowly soaked into the ground underneath a concrete transformer pad.

Risk Evaluation:

The immediate risk is extremely low. It is non-PCB oil contained in the soil under the concrete pad.

Potential Env. Impacts:

Potential impact are likely to be limited to the soil under the pad. The closest well appears to be a monitoring well owned by the city approximately 1900 feet NW of the spill location. The well record indicates a depth of 15 feet drilled and a static water level as being dry. The soils are described as being sandy lean clay, rather stiff.

Action Taken/Planned:

The location of the release is in the area of the grain storage operation for the farm. OTP personnel will attempt to shovel out impacted soil as best as they can. There are many large utility lines underground in the area of the concrete pad.

Wastes Disposal Location:

Any recovered waste will be taken to our Central Stores location for disposal at a later date.
