Truck loaded produced water at the Hess EN Weyrauch B H3-H8. Trailer load valve malfunctioned causing water to leak from tank into load hose. Once load hose filled it leaked out the cap into the hose tray on the trailer. Water ran from hose tray onto the ground for approx 4.5 miles on lease road to 94th Ave NW to 50th St NW to the BOH RUUD SWD where the leak was stopped. Produced water leaked onto the crown of the road, not into the ditch, and onto the BOH RUUD SWD pad.
