10. **Topics** in Water Treatment and Distribution may include.

SDWA Update; Operator Certification; Overview of Water Treatment Rules; RTCR Update; Stage I & II Disinfectants/Disinfection By-products Rules; Filtration; Chlorine Meters and Measurements; Disinfection of Pipes and Reservoirs; Fire Hydrants; Groundwater Rule; Lead and Copper Rule; Math; Cross Connections; Pumps; System Security; Fluoridation; Well Head/Source Water Protection; Others.

11. **Topics** in Wastewater Treatment and Collection may include.

Wastewater Basics; History of Wastewater Treatment; Troubleshooting; Physical Aspects of Lagoons; Wetland Systems; Microbiological Life in Ponds; Collection Systems; Operator Certification; Math; Discharge Permits; Lift Station Rehabilitation; Stormwater Update; Pond Construction: Others.

12. All operators working in community and non-transient noncommunity public drinking water treatment and/or distribution systems which serve a population of 3,300 or less are eligible for reimbursement. Please pick up the appropriate forms during the training sessions. After payment to the North Dakota Water and Pollution Control Conference and/or state is made, you may apply for reimbursement.

Because our Division of Accounting will now be issuing the checks, they require that each individual operator or System (City) requesting reimbursement must also submit a signed IRS W-9 Form with the request.

If the operator does not want to complete the W-9, then the option is to indicate on the Operator Reimbursement form that the city should receive the reimbursement. The city will submit a W-9 and then the city can reimburse the operator.
