

Public Notice of Opportunity to Comment on a Draft Permit for the Grand Forks Air Force Base Issued under the North Dakota Hazardous Waste Management Rules

The North Dakota Department of Environmental Quality, Division of Waste Management, plans to reissue a permit to the:

Department of Defense Grand Forks Air Force Base 460 Steen Blvd Grand Forks AFB, ND 58205

Background

The Grand Forks Air Force Base is a military installation supporting the nation's defense. The Grand Forks Air Force Base has applied for a permit to continue the implementation of corrective action at contaminated sites on the Base. The Grand Forks Air Force Base has an existing permit issued under the North Dakota Hazardous Waste Management Rules which allows corrective action implementation. The existing permit has an expiration date of March 1, 2025. The North Dakota Department of Environmental Quality (NDDEQ) believes that a permit which meets the requirements of the North Dakota Hazardous Waste Management Rules to protect human health and the environment can be issued to the Grand Forks Air Force Base and has prepared a Draft Permit with appropriate conditions according to the requirements of Chapters 33.1-24-06 and 33.1-24-07 of the North Dakota Administrative Code (NDAC).

Public Comment and Hearing

As required by NDAC § 33.1-24-07-06, the Draft Permit for corrective action on the Base will be available for public review and comment for forty-five (45) days, beginning January 6, 2025, and ending February 20, 2025. During that period any interested person may submit written comments and request a public hearing by stating the nature of the specific issues to be raised. A 30-day notice will be provided before any hearing is scheduled. The NDDEQ, Division of Waste Management, will consider all comments prior to taking any action on the permit.
