BACKGROUND:

The North Dakota Department of Environmental Quality (Department) received a permit application for a renewal for the Rolla Solid Waste Management Facility.

The City of Rolla currently owns and operates an inert waste landfill regulated under Permit 0358 on 8.55 acres located in SW ¼ of the NW ¼ and the NW ¼ of the SW ¼ of Section 21, Township 162N, Range 69W in Rolette County, ND. The Rolla Solid Waste Management Facility is proposing to renew their permit to continue operating an inert waste landfill. The facility was first permitted in 2011.

The Department believes that a permit which meets the requirements of the North Dakota Solid Waste Management Rules and is protective of human health and the environment can be issued to City of Rolla and has prepared a Draft Permit for public review and comment.

PUBLIC COMMENTS AND HEARING

As required by Section 33.1-20-03.1-03 of the North Dakota Administrative Code, the Draft Permit will be available for public review and comment for thirty (30) days following publication of the Public Notice. The public comment period begins January 1, 2024 and ends February 14, 2024. During that period, any interested person may submit written comments and request a public hearing by stating the nature of the specific issues to be raised. A fifteen (15) day notice will be provided before any hearing is scheduled. The North Dakota Department of Environmental Quality will consider all comments prior to taking any action on the permit.
