- •Filled out by city personnel
- Required to answer all questions on form
- Requires signature of specific persons
  - •Are YOU one of those persons?
  - •A representative of the city or rural fire dept.
  - •A District Health Unit Representative

The North Dakota Air Pollution Rules, North Dakota Administrative Code (NDAC) Chapter 33-15-01-07 allows variances in instances of "exceptional circumstances" as follows:

- 1. Whereupon written application of the responsible person or persons the department finds that by reason of exceptional circumstances strict conformity with any provisions of this article would cause undue hardship, would be unreasonable, impractical, or not feasible under the circumstances, the department may permit a variance from this article upon such conditions and within such time limitations as it may prescribe for prevention, control, or abatement of air pollution in harmony with the intent of the state and any applicable federal laws.
- 2. No variance may permit or authorize the creation or continuation of a public nuisance, or a danger to public health or safety.

Due to considerations on pollution, the Department encourages better management for wood wastes, such as waste reduction, reuse of wood materials (such as lumber, pallets, use as firewood for heating, etc.), grinding the materials to make a mulch or compost medium, and/or utilizing a permitted air curtain destructor. Routine trade waste (pallets, manufacturing waste, etc.) may not be allowed. Additional guidance is available from the Department.





### A VARIANCE APPROVAL TO OPEN BURN IS SUBJECT TO THE FOLLOWING:

- Oil, rubber, asphalt, asphalt shingles, upholstered furniture, plastics, fabrics, insulation, foam, treated wood, electronics, appliances, household waste, hazardous materials, batteries, chemicals, and other materials which produce unreasonable amounts of air contaminants may not be burned.
- Grass and leaves which smolder and do not burn readily shall not be burned. The material must be dry enough to burn cleanly and shall not contain noncombustible matter or items such as metal, glass, plaster, sheetrock, concrete, brick etc.
- 3. Care must be used to minimize the amount of dirt on the material being burned.
- The initial burning may begin only between three hours after sunrise and three hours before sunset, and additional fuel may not be intentionally added to the fire at times outside those limits.
- The burning must be conducted in such a manner to ensure that the fire will not spread to any material not approved for burning.
- Prevailing winds at the time of burning at the above location must be away from any nearby city or occupied residence and must be away from any airport or landing strip within one mile (1.61 kilometers).
- 7. The burning may not be conducted adjacent to any highway or public road so as to create a traffic hazard.
- The burning may not be conducted in such proximity to any Class I area that the visibility of such area is adversely impacted, as defined in Chapter 33-15-19 of the North Dakota Air Pollution Control Rules.
- 9. The local/appropriate fire department must be notified at least two (2) hours prior to burning.
- 10. Notification to the Department is required prior to starting the burn.
- Burning activities must be attended and supervised at all times burning is in progress.
- 12. Burning is prohibited if the fire index is in the "extreme" category as issued by the National Weather Service.
- If state or local fire officials determine conditions to be unsafe for open burning, such burning must cease until conditions are deemed to be safe by such officials.
- 14. The variance must be utilized within sixty (60) days of the Department approval date.





# What do you do if your burn pile contains prohibited items?

Sort materials and separate into appropriate piles, removing all but the clean burning non-trade-waste wood from the burn pile.

## What is a Trade Waste?

**33-15-01-04. 50. Definitions.** "Trade waste" means solid, liquid, or gaseous waste material resulting from construction or the conduct of any business, trade, or industry, or any demolition operation, including wood, wood containing preservatives, plastics, cartons, grease, oil, chemicals, and cinders.

### What is a Trade Waste?

A quick way to remember....

Any waste acquired while conducting business, is considered trade waste.

# Trade Waste Can you burn Trade Waste?

**33-15-04-01. Refuse burning restrictions**. No person may cause, conduct, or permit open burning of refuse, trade waste, or other combustible material, except as provided for in section 33-15-04-02 or 33-15-10-02, and no person may conduct, cause, or permit the conduct of a salvage operation by open burning.

But the burn variance application says "clean wood". Aren't pallets and branches clean wood?

**Considerations:** (read your application carefully!)

•ls it an exceptional circumstance?

•The Department encourages better management of wood wastes. Routine trade waste (pallets, manufacturing waste, etc) may not be allowed.

### Highlights

- Burn variances are only allowed for "exceptional circumstances"
- Allowable items include ONLY clean wood
- Separate grass clippings from wood. They smolder and shouldn't be burned
- Burnable wood piles should contain only trees and branches- avoid stumps with lots of soils
- Trade wastes are not allowed to be burned.
