BACKGROUND:

The North Dakota Department of Environmental Quality (Department) received a permit application for a permit renewal for the City of Jamestown's municipal solid waste landfill facility.

The City of Jamestown currently owns and operates a municipal solid waste (MSW) landfill, regulated under Permit 0213. The facility lies within Section 36, Township 140 North, Range 63 West in Stutsman County, ND. The city is proposing to renew their permit to continue operating a MSW landfill. The facility was first permitted in 1976.

The Department believes that a permit which meets the requirements of the North Dakota Solid Waste Management Rules and is protective of human health and the environment can be issued to City of Jamestown and has prepared a Draft Permit for public review and comment.

PUBLIC COMMENTS AND HEARING

As required by Section 33.1-20-03.1-03 of the North Dakota Administrative Code, the Draft Permit will be available for public review and comment for thirty (30) days following publication of the Public Notice. The public comment period begins January 3, 2024 and ends February 1, 2024. During that period, any interested person may submit written comments and request a public hearing by stating the nature of the specific issues to be raised. A fifteen (15) day notice will be provided before any hearing is scheduled. The North Dakota Department of Environmental Quality will consider all comments prior to taking any action on the permit.
